PPE - Review of PPE for fall arrest at height

Objective

To train participants to become Competent Persons in the performance of periodic PPE inspections, according to different regulations.

Aimed at

People, designated by the employer, responsible for carrying out the inspection of PPE against falls from height manufactured by Singing Rock and any other manufacturer; managers of the company's PPE against falls from height; people in charge of the company's prevention of occupational hazards; people in charge of teams of workers using PPE against falls from height; PPE against falls from height inspection service providers; users of PPE against falls from height who wish to obtain training and/or recognition by the equipment manufacturer; etc.
